

BY-LAW NO. 27

CANADIAN CHARITABLE ORGANIZATIONS EXEMPTIONS

RESOLVED, as a By-Law of the Town of Yarmouth, pursuant to Section 71 of the Municipal Government Act, that:

1. The following property of the following registered Canadian Charitable Organizations, be exempt from real property taxation to the extent hereinafter set out:
